### **Convention Center & General Information**



#### Wifi Access

Free public Wi-Fi is available throughout the Raleigh Convention Center. Speakers and Exhibitors who need improved connectivity may contact the conference help desk in the main lobby for assistance.



#### For Nursing Mothers

Mamava nursing pods are available on the **Main and Mezzanine Levels.** Nursing pods have hospital-grade surfaces with two built-in benches, shelving, and mirror. Outlets and USB ports are available. Two ventilation fans provide 32dB of white noise and are capable of air-change rates of at least 79 ACH.



#### Visit Raleigh

The **Raleigh Visitor Information Center** (VIC) is open from 8:30AM – 5:00PM, Monday through Saturday, to help you with nearby restaurant recommendations, find things to do downtown, and advise on transportation options. 

#### Comprehensive Crash Data Starts with You: Crash Reporting to Advance Safety for People Who Walk, Bike, and Roll

People who walk, bike, or use e-scooters or other forms of micromobility represent a disproportionate share of fatalities and severe injuries in roadway traffic crashes. There are many factors that may contribute to a crash and resulting severity, including roadway user maneuvers, type of roadway, type of vehicle, weather conditions, and more. These factors are important to capture for better understanding not only why crashes happen but also next steps for improved safety and interventions. Crash reporting is also important in how State laws are enforced.

Law enforcement officers play a critical role in taking the first steps in reporting crash data. In this workshop, Sarah O'Brien, research associate, and Sgt. Brian Massengill will share the importance of capturing accurate data at the scene of the crash and the life cycle of crash data. They will also link specific crash scenarios to specific State laws related to pedestrian and bicyclist safety to give a more comprehensive picture of those scenarios. They will also explore how crash data and enforcement of specific safety laws can better inform strategies and solutions to improve roadway safety.

#### Pedestrian and Bicyclist Crash Reporting - Strategies to Effectively Capture Facts

Accurate pedestrian and bicyclist crash data is important, especially since the rate of severe crashes resulting in a fatality has been increasing. According to the Insurance Institute for Highway Safety, pedestrian crash deaths have increased 51 percent between 2009 and 2019 (https://www. iihs.org/topics/fatality-statistics/detail/pedestrians) while bicycle crash deaths have increased 36 percent between 2011 and 2019 (https://www.iihs.org/topics/fatality-statistics/detail/bicyclists). This presentation will highlight what has been observed to work in pedestrian/bicycle crash reporting and strategies for improvement.

#### Hands-on Challenge (1.5 CEUs)

This session will improve CPS technical knowledge by giving participants hands-on experience with new car seats and CPS Technician tools that goes beyond what is covered in the certification course. In order to earn a CEU for this session, Technicians must complete five of six exercises (described below) and complete the signature form.

#### **Hands-on Stations:**

Rotating Car Seats – participants will explore and answer questions about new car seats that rotate on a base. (For example the Nuna Revv)

Load Legs and anti-rebound bars – participants will explore and answer questions about car seats with load legs and anti-rebound bars.

Lock-Offs – Intimidated by lock-offs and lock-off look-a-likes? Participants will get hands-on practice with a variety of car seats with both lock-offs and seat belt pre-tensioners to make sure they are identifying and installing the car seats correctly.

LATCH Manual – participants will use the LATCH manual to answer questions commonly encountered in the field about car seats, vehicles, and LATCH locations.

Car Seat and Vehicle Recalls – participants will take a deep dive into car seat recalls including looking the associated documents on NHTSA's car seat recall page, identifying recall information on car seat manufacturer websites, and checking recalls on their own vehicle using https://checktoprotect.org/

Inflatable Seat Belts - participants will identify which vehicles have inflatable seat belts, how to identify them, and will explore car seat owners manuals to determine which car seats can be installed with an inflatable seat belt.

## The Power of Collaboration: Trauma Centers' Injury Prevention Road Safety Efforts and How We Can Help You

Data on traumatic injuries informs direct program development and support by injury prevention (IP) specialists at trauma centers across the country. With the amount of injuries seen at trauma centers from car, bicycle, and pedestrian crashes, IP specialists are tasked with addressing road safety to reduce those injuries, either through original programming or partnership with community groups and agencies. #### DADSS and the Elimination of Drunk Driving Through Technology

Alcohol-related fatalities continue to represent nearly one-third of all traffic fatalities in the US. The Driver Alcohol Detection System for Safety, or DADSS, is an in-vehicle driver alcohol detection system that could, if deployed in all vehicles, virtually eliminate drunk driving. This public-private partnership between NHTSA and the auto manufacturers is developing and testing the DADSS technology on two tracks: a breath-based system that monitors driver alcohol content by sampling the driver's breath, and a touch-based system that reads the driver's BAC through the skin when the driver touches a sensor location in the vehicle. If the driver's BAC is determined to be above the specified limit, the car will start but will NOT engage, preventing an impaired individual from driving.

Commercial Driver License (CDL) holders have the privilege of operating 80,000-pound vehicles, and with that privilege comes greater training, licensing expectations, and responsibility. CDL holders face lifetime disqualification from operating a commercial motor vehicle (CMV) if criminally convicted of a severe form of human trafficking. This presentation will provide an overview of human trafficking on our highways and educate attendees about the Federal "No Human Trafficking on Our Roads Act" (NHTRA), which was signed into law on January 1, 2018. Under this rule, states have until September 23, 2022, to comply with a mandate to keep human traffickers off of our nation's roadways. Psychological Biases, Nudging Countermeasures, and the **Traffic Safety System** 

Speaker: Dr. Emanuel Robinson

A key component of the traffic safety system focuses on psychological countermeasures, including relatively recent advances drawn from the field of behavioral economics.

Behavioral economics emerged out of traditional economics to incorporate psychological insights and biases to understand decision-making. "Nudges" and other psychological countermeasures designed to indirectly guide individuals to safer behaviors are powerful and relatively low-cost tools in the traffic system safety toolbox. Identifying reasons for biases and limitations of thinking along with mitigation strategies in traffic safety (including nudges) is the focus of this talk. Examples highlighted will include approaches in design, messaging, outreach/education, and enforcement drawn from recent USDOT and State/local DOT work, as well as widespread international implementations (e.g., Monderman's Psychological Traffic Calming). The discussion will include reasons why behavioral economics approaches work in many situations, principles that can be applied to different contexts, practical lessons learned, and recommendations for implementing these approaches in traffic safety.

#### The Comprehensive Cost of Rail Incidents in North Carolina

Unlike highway crashes and incidents, rail related incidents incur a host of industry-specific impacts that can be exponentially more costly. There has been a growing need for an accurate measure of rail incident costs that reflects the broad spectrum of events that occur on the railway, including highway-rail grade crossing crashes, rail trespassing crashes, and non-crash delay incidents. The Institute for Transportation Research and Education and Planning Communities, under the leadership of the North Carolina Rail Division, has developed a user-friendly cost tool that is capable of estimating the comprehensive set of costs that result from a rail incident. The tool evaluates costs stemming from property damage, injuries and fatalities, delay, rerouting, and supply chain events, as well as emergency responder costs.

Pedestrian strikes are a key subset of the many types of rail incidents that occur on North Carolina's rail network. Crossing deaths of pedestrians (as opposed to those of motor vehicle occupants) have increased from approximately 10 percent of total crossing deaths in the late 1970s to 35 percent in the middle 2010s. As part of this presentation, safety considerations related to pedestrian strikes will be closely examined. For this presentation, Roger Smock will discuss the importance of rail safety and countermeasures.

Steve Bert will demonstrate how the Comprehensive Cost of Rail Incidents Cost Tool can be used to illuminate the economic and social impacts resulting from rail incidents and show how the tool can be used to generate support for countermeasures and expanded safety training.

To improve not just the community but the lives of everyone living in there.
